

LOCATION High Ridge is located on the northeast corner of Highway "E" and Golf Road in the Town of Delafield

1. All lots in High Ridge are restricted to the erection of a one story, one and one half story, two story or split level single family residence and attached garage

BASIC RESTRICTIONS 2. The minimum living area of the home is as follows:

- a. One story no less than 2,000 square feet total.b. One and one-half story no less than 1,200 square feet on the first floor.

- c. Two story no less than 1,100 square feet on both floors.
 d. Split level no less than 1,400 square feet on the upper two levels.
- e. Bi-level no less than 1,400 square feet on the upper level. These restrictions are subject to the minimum floor area requirements for the Town of Delafield.
- 3. All exterior walls shall be constructed of natural materials.
- 4. Minimum setbacks shall be 50 feet from the front and 20 feet from each side
- 5. All building plans, exterior design and color must be approved by Siepmann Realty Corporation
